RULES OF PROCEDURE

Article I – Name and location

A club named "Collectif M.I.A., Miaistes, Inspirons l'Avenir" (Inspire the future) was incorporated as a formal Association on March 1st 2015 by enthusiasts owners of a Mia car, produced by the Mia Electric Company in Cerizay (dpt 79).

Article II – Objectives

The M.I.A. Collectif and its members have the following objectives:

- Participate in the pleasure of owning an original and unique electric vehicle produced in small series from 09/2011 to 12/2013.
- Identify Mia cars placed on the market during this period.
- Communicate and learn about the history and future of the company Mia Electric, with support for any potential production recovery (not known to this day).
- Collect technical and practical information about Mia vehicle, technologies as well as about related vehicles, to meet the car services needed by the members of the Collectif.
- Promote the owners linkage to Mia after-sales service professionals, M.I.A Collective's partners.
- Organize friendly meetings between Miaistes throughout France and Europe.
- Ensure technological survey of vehicles likely to succeed to the Mias.

Article III – Ethics

The M.I.A. Collectif gives itself freely the means to achieve its purpose in accordance with its rules.

The M.I.A. Collectif has neither political vocation nor religious preference, it welcomes any owner of a Mia car, except restrictions mentioned below, and reserves the right to accept or reject any participant who is not an owner.

It encourages clean mobility using renewable energy.

It does not pursue any profit-making activity.

Restrictions: Temporarily, it excludes any potential member present employee or ex-employee of one of the companies involved in the court decisions in progress, until the complete resolution of the closeout of Mia Electric. Any supporting documentation may be required in case of doubt.

Article IV – Financial Resources

The M.I.A. Collectif relies on the membership dues, donations or any profits of its operations. If appropriate, it may distribute part of its surplus to an Association promoting green travel, chosen by the Collective's Bureau.

Article V – Eligibility

May be admitted as a member, Mia vehicle owners, of all types, countries and years, produced by the Mia Electric Company in Cerizay (dpt 79) (1200 vehicles produced), and any person invited or working for the Collectif, in accordance with Article III.

Membership becomes effective only after an application form is completed and signed with the acceptance of these rules and payment of the subscription fees.

To be admitted to the Collectif, each new membership request will be accepted in accordance with the Bureau.

Article VI – Contributions

Participants must pay no later than the end of January, a valid membership fee for the calendar year, and non-refundable "prorated" in case of departure during the year.

The amount of the fee is set annually by the Bureau. It is established based on a fee per each owned Mia car.

Article VII – Resignation and exclusion of members

Members can resign at any time. They must, in advance, meet their obligations to the Collectif. The resignation is sent to the Collectif headquarters.

The Collective's Bureau may expel a member at any time in case of non-compliance with these Rules of Procedure or any action offending the interests of the Collectif.

Article VIII – Composition of the association

The Bureau consists of:

- A President
- A or two Vice-President (s)
- A or two Secretary (ies)
- An Assistant Secretary
- A Treasurer
- An Assistant Treasurer

Including a representative of the Automobile Club of Deux-Sèvres.

Volunteer regional delegates may be appointed by the Bureau to convey the national information and help identify and regional meetings.

Subscribers are not limited in number.

They can be either a physical or legal person including an institution.

Article IX – The Bureau

The Bureau meets periodically at variable frequencies, depending on the Collectif activities.

It shall be convened no later than 15 days in advance by the President in written form or telephone or email.

Its responsibilities are as follows:

- 1) Examination to the admission of new members
- 2) Change, if necessary, the Collectif Regulations which become immediately binding on all members
- 3) Acceptance of accounts and budget
- 4) Determination of the annual membership fee
- 5) Programming activities.

The Collective's Bureau takes its decisions by a majority of members present or represented.

At the end of each year, the Secretary shall prepare an activity report he will present to the Bureau and to all members present to the Annual General Meeting.

The treasurer presents a reporting of the year's accounts in the same terms as the secretary. He is in charge of keeping the bank account of the Collectif, for which the president and the treasurer shall deposit their signature to the bank.

The Bureau members are selected among the members of the Collectif after an act of candidacy to volunteer. In case of multiple applications, a vote will be carried out during the General Meeting. Each owned Mia car for which a fee has been paid can qualify for one vote.

The Bureau may be renewed by thirds every year (2 positions concerned every year); if a member resigns before the expiration of his term, there will be immediately someone else appointed temporarily through self-designation or vote from the Bureau until the next General Meeting; in case of a lack of applications at renewal term, the person currently in office will stay for another year, his position being renewable annually.

Article X – Rules

The management rules and the operations of the Collectif are set by the Bureau and each member of the Collectif accepts them.

Article XI – Signature

The Collectif is bound by the signature of the President who can, if necessary, give power to another member of the Bureau.

Article XII– Responsibility

The Collective is responsible for the actions of its authorized representatives as they carry out their duties. Its liability is limited to the Collective's financial resources.

The Collectif cannot be held responsible for the actions of its members. In particular, each member undertakes, during outings, it is required to respect driving rules, to withhold a valid driving license and insurance for his vehicle which complies with current standards.

Violators of these rules will be immediately excluded from the Collectif.

Article XIII – Insurance

Each member, upon subscribing, provides a copy of the vehicle insurance policy, as well as a copy of personal private liability insurance.

Article XIV – Dissolution of the Collectif.

The Collectif may be dissolved upon decision of the Bureau.

If, then, accounts and treasury have a positive balance, the money will be donated for the development of renewable energy.
